The Lady Warriors saw another post-season of playing up in class 3A. In the opening round match against North Harrison, the Warriors dropped the first two sets (26-28 / 24-26). With the match and the season on the line, the Warriors saw themselves down late in the third set 21-24. Chloe Wiseheart stepped back behind the service line, and the Warriors fought off three match points to pull out the set win 26-24. Behind the defensive game of Abby Vancampen and the late offensive surge from Jolie Miles and Ella Baldwin, the Warriors won the last two sets (25-18 / 15-9), and the match, to move onto the semi-finals. The Warriors started off slow and were unable to match the fire power of Scottsburg in the semi-finals, dropping the first set 15-25. Thanks to aggressive serving from Adeline Baldwin and Chloe Wiseheart, the second set was much closer. Front row defense from Karlyn Denny and Ella McCoy helped funnel hits right to the defenders. However, in the end, Scottsburg was able to pull out the set (25-27) and wrap up the match in the third set (17-25). The loss saw the end of CAI Volleyball careers for Adeline Baldwin, Mollie Hoagland, Ella McCoy, Jolie Miles and manager, Karson Abbott.
