**COVID-19 Parent/Guardian Agreement**

The novel coronavirus COVID-19 has been declared a worldwide pandemic by the World Health Organization. COVID-19 is contagious and is believed to spread mainly from person-to-person contact.

Christian Academy Schools continue to follow updates from the CDC, the state of Kentucky/Indiana, and local health departments and will put in place reasonable preventative measures to reduce the spread of COVID-19 at each school. However, even though reasonable measures will be put into place, the school cannot guarantee that you or your child(ren) will not become infected with COVID-19.

**Agreement:**

**Temperature and Health Checks:** All students will need to undergo daily temperature and health checks. We ask that you do this prior to leaving your home.

- Your child will need to remain home as soon as **any** illness is suspected. Do not come to campus sick.
- If your child has a fever of 100.4°F or higher **AND/OR** other COVID-19 symptoms **OR** if your child exhibits any other illnesses while on campus, a parent/guardian will be contacted for immediate pick-up (within one hour of initial contact). It is recommended that you contact your healthcare provider and follow his or her guidance on your student returning to activities.
- Students will be required to be fever/symptom-free for **24 hours** without fever-reducing medications to return to campus **IF a healthcare provider has determined the fever of 100.4°F AND/OR other symptoms are related to an alternative explanation (Strep, influenza, etc.).**
- If your student is sent home with COVID-19 symptoms, it is recommended that you consult your healthcare provider and that your student be tested so that the proper contact tracing can be done.
- If your student or a family member residing in their residence receives a positive COVID-19 test result, please notify the school as soon as possible. Please follow the guidance and direction of your medical provider or health department regarding self-isolation.
- Any student awaiting the results of a COVID-19 test should remain home until the test result has been received.

**Waiver:**

- **By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending activities at Christian Academy and that such exposure or infection may result in personal injury. I understand that the risk of becoming exposed to or infected by COVID-19 at Christian Academy may result from the acts or omissions of myself and/or others, including, but not limited to, Christian Academy employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may incur in connection with my child(ren)'s attendance at school activities. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Christian Academy, its employees, agents, and representatives, of and from all claims, actions, liabilities, and damages of any kind arising out of my child(ren)'s attendance at school activities.**
