



Dear Parent(s)/Guardian of 6th Grade Students,

Welcome to Middle School at the Southwest Campus of Christian Academy of Louisville!

As your child enters 6th grade, it is a state law requirement that their health record be updated. **The following 2 items are required for admission.**

1. **PREVENTATIVE HEALTH CARE EXAMINATION FORM** - A NEW school physical (also called a Preventative Health Care Exam) is mandatory for 6th grade admission. **This physical must be on the Kentucky Department of Education School Physical Form.** The correct form for your child's school health record is available at your physician's office. **Please Note:** The Kentucky Department of Education School Physical Form is NOT the same as the Kentucky Athletic Form. Sports physicals WILL NOT BE ACCEPTED.
2. **KENTUCKY IMMUNIZATION CERTIFICATE** - There are specific immunization requirements for 6th grade (11 year olds). Your child may or may not have had these immunizations. A complete listing of required immunizations is on the back of this letter. We recommend that you discuss the following immunizations with your physician as they are required and must be listed on the certificate. They are as follows: **1 dose of Tdap, 2 doses of Varicella, and 1 dose of MCV or MPSV.** Your child's complete immunization record must also be on the **Commonwealth of Kentucky Immunization Certificate.** This form is available at your doctor's office. Any out of state immunizations must be transferred to a Kentucky Certificate. It must be signed by the physician's office and have a valid expiration date listed.

All forms must be turned in at Back-to-School Drop-In on **Monday, August 9 from 2:00-6:00 PM** in order to receive your class schedule and locker assignment for Middle School.

As you know, these documents are required by all schools by state law. We must be in compliance to insure admittance of our children to school. Thank you in advance for your attention to this important matter.

REQUIRED IMMUNIZATIONS

Immunization Requirements for K - 5th Grade

- 3 doses of Hepatitis B
- 4 or 5 doses of DTP/DTap/DT
- 3 or 4 doses of Polio/IPV
- 2 doses of MMR
- 2 doses of Varicella
- 2 doses of Hepatitis A

Immunization Requirements for 6th - 8th Grade

- 3 doses of Hepatitis B
- 4 or 5 doses of DTP/DTap/DT
- 3 or 4 doses of Polio/IPV
- 2 doses of MMR
- 2 doses of Varicella
- 2 doses of Hepatitis A

***** PLEASE NOTE THE SHOTS LISTED BELOW THAT ARE REQUIRED FOR STUDENTS STARTING 6TH GRADE.** These are typically given when a child turns 11.

- 1 dose of Tdap
- 1 dose of Meningococcal

All students must have a current Immunization Certificate, Preventative Health Care Exam, and a state-issued birth certificate on file in the school office as this is required by state law. Christian Academy reserves the right to withhold attendance of any student who fails to comply with these state regulations until the forms are received within a timeline deemed acceptable by administration.
