Admissions Policy

Subject to the faith-based standards and beliefs stated in the Christian Academy policies and procedures, Christian Academy School System admits students of any race, gender, color, nationality or ethnic origin to all rights, privileges, programs and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, gender, color, nationality or ethnic origin in administration of its educational policies, admissions policies, tuition grant program, athletic and other school-administered programs.

Christian Academy was established on the biblical principle that God gives parents the primary responsibility for educating their children. The school enters into a partnership with parents and Christian educators to teach academics in the context of a Christian worldview. Christian Academy's policy is to offer enrollment to students of Christian parents who desire a Bible-based education with academic excellence for their children. The Christian Academy staff partners with families who also teach their children what it means to live a Christian life regarding personal and family relationships. (See Section G.1.3 and G.1.4)

Notwithstanding anything else in this handbook, Christian Academy reserves the right to select students and families on the basis of academic performance, Christian commitment, lifestyle choices and personal qualifications including a willingness to cooperate with our administration and policies. Program Highlights

We seek to provide a loving, Christian environment with Christian teachers who celebrate the individuality of each child and recognize each as a precious gift created by God.

Children have the opportunity to engage in a variety of learning centers throughout the day. Each week there is a different thematic unit in the classroom. The theme is carried out through the centers as well as individual activities such as art, crafts and music. The children also have the opportunity to spend time with their teachers by working in small groups in the area of letter recognition, handwriting, math and science.

Each morning there is circle time where children engage in calendar, pledges, Bible story and songs. Children have daily time scheduled for gross motor play either in our gym or outdoor playground.

We have weekly chapel service for all classes where the Bible story comes alive through song, Bible readings and Bible stories.

We believe in partnering with families to help children grow in wisdom, stature and favor with God and men. (Luke 2:52)

Program Certification

The English Station Junior Academy is a member of the Association of Christian Schools International (ACSI) and is licensed by the State of Kentucky.

Our teachers and staff participate in 15 hours of professional development every year which is centered around current trends in Early Childhood Education. Teachers and staff are also First Aid and CPR certified.

Our Junior Academy is open to children the ages of 3 - 4. Children must meet the age requirements on or prior to August 1.

The full-day Junior Academy (Preschool) program is available for students, Monday-Friday, from 7 a.m.- 4 p.m. A separate Junior Academy After-School Care program will be offered from 4 p.m. - 6 p.m. at an additional cost for families who choose to register.

2023-2024 Schedule of Tuition and Fees

The mission of Christian Academy School System is to develop students with a heart for God who grow as Jesus did in wisdom, stature and favor with God and men.

NEW STUDENTS:

Application Fee – A fee of \$100 per Junior Academy student must accompany each application. The application fee is non-refundable.

RETURNING STUDENTS:

Continuous Enrollment Fee – A non-refundable fee of \$100 per Junior Academy student is due **February 10, 2023**. This fee will be paid in conjunction with the online continuous enrollment process through FACTS.

TUITION/FEE POLICY

Tuition and other fees are necessary in order for Christian Academy to fulfill its mission of developing students with a heart for God. In support of this, parents are expected to commit themselves to meet financial obligations promptly in accordance with Biblical stewardship and to comply with the following policy:

The Continuous Enrollment Fee is non-refundable unless for any reason Christian Academy does not readmit the student. If parents withdraw their student's enrollment for any reason, the Continuous Enrollment Fee is non-refundable.

The school has contracted with FACTS Tuition Management for the processing of all tuition payments. The following payment options are available through FACTS:

- Annual Payment due June 15, 2023.
- Monthly Payments (August through May). A \$50 annual processing fee per family is required for using this service and will be automatically drafted from your account by FACTS within 14 days of the agreement being posted to the FACTS system.

A one-month notice must be given for any withdrawals prior to the end of the school year because the hiring of teachers and staff and the ordering of classroom materials are based upon anticipated enrollment. Notice must be provided by completing the Withdrawal Form located in your Web Forms in FACTS Family Portal.

Tuition that becomes two months past due will subject the student to being withheld from attending school. Because tuition is calculated on an annual basis, no adjustments will be made for absences, holidays or unscheduled closures.

TUITION ASSISTANCE

Tuition assistance awards are based on the family's demonstrated need as determined by a third-party agency that makes financial needs assessments for private and Christian schools. Each award is made for one year only, based on the availability of tuition assistance funds.

ADDITIONAL FEES

- **Missed Payment Fee** – Missed payment fees are assessed by FACTS if payment is not received as scheduled.
- **After-hour Fee** – An after-hour fee of \$2.00 per minute per student will be charged beginning at 4 PM (school-day program) and 6 PM (after-school program).
- **Returned Check Fee** – A \$25 returned check fee will be charged on all returned checks.
- **Miscellaneous Expenses** – During the course of the school year, other expenses may be incurred for various services or activities. Notice of at least two weeks will be given before such a fee is due, and participation in the activity is typically optional.

AFTER-SCHOOL CARE PROGRAM

- Families may opt to register to attend the After-School Care program from 4 PM to 6 PM.
- Registration opens in Spring 2023.
- Cost is \$1600/school year per student (\$800/semester), scheduled through FACTS.
- An after-hour fee of \$2.00 per minute per student will be charged beginning at 6 PM.
- Withdrawals from the After-School Care program must be made at the change in semester. Notice should be provided in writing to the Business Office at least one month in advance.

SUMMER SESSION (7 AM – 4 PM only)

- Families may opt to register to attend the Summer Session during June and July. Registration for this program will occur each spring.
- An activity fee will be assessed for each Summer Session.

Frequently Asked Questions

Why Consider Financial Assistance?

Christian Academy is committed to making Christian Education as affordable as possible. 29% of our K-12 CAL students receive tuition support through financial assistance and discount programs, totaling over \$2.2 million in support. We recognize the sacrifices of a Christian lifestyle and take medical expenses as well as charitable contributions into account.

Who May Qualify for Tuition Assistance?

All prospective and enrolled Jr. Academy-12th grade students may apply. New families may contact the Tuition Assistance Coordinator for information.

How Do I Qualify for Tuition Assistance?

A third party administrator, FACTS Grant & Aid Assessment (FACTS), is used to determine eligibility. A family's application, along with financial information, goes directly to FACTS. All tuition assistance awards are based on need (as determined by FACTS) and the total amount of assistance available. Tuition assistance awards may vary each year. Families must reapply each school year.

2023-2024 POLICY

Advance registration through FACTS Family Portal is required to participate in the Junior Academy After-School Care Program (ASC). After-School Care fees will be collected through your FACTS agreement through automatic withdrawal along with scheduled tuition payments.

PROGRAM INFORMATION:

- JA ASC begins at 4:00 PM and ends at 6:00 PM. A late pick-up fee of \$2.00/minute/student is assessed and will be invoiced and paid through FACTS Tuition Management.
- As always, Junior Academy staff members will serve your children during the After-School Care hours. All staff members will continue to meet state requirements as well as Christian Academy School System standards to work with your children.

PROGRAM RATES:

\$1600 annually (\$800/semester) through FACTS Tuition Management. Payments will be automatically withdrawn on the same date and same account as your scheduled tuition payments.

PROGRAM POLICIES:

- Registration of new students and withdrawals of participation may only change at the beginning of the second semester with a one-month written notice to the Business Office. Opting in and out during the course of a semester is not permitted.
- No care will be provided for holidays, early dismissals, or unscheduled closures. Rates are calculated on a semester basis; therefore, **no adjustments will be made for missed days, holidays, early dismissals, or unscheduled closures.**
- After-School Care enrollment may be suspended for any student whose account becomes two months past due.
