Scholarship Rules - 2025

In an effort to recognize and develop pro-life leadership and convictions among Southern Indiana's young adults, Right to Life of Southern Indiana will award a **\$500 Pro-Life Scholarship** to a student who is either a graduating high school senior or a college undergraduate.

Requirements

Students must meet the following requirements to be eligible:

1. Are graduating high school seniors (home schooled students are eligible) or returning college undergraduates who will not complete their undergraduate studies during 2025.
2. Are students either living in or attending school in Clark, Floyd, Harrison, and Crawford counties in Indiana.
3. Have been accepted at or are currently attending a college or university.
4. Have completed the application requirements (see below).

Application

1. Write a short summary of your pro-life activities. In this summary, detail pro-life activities in which you have been involved. This might include, but is not limited to, making a pro-life speech in school, attending a hearing concerning pro-life legislation, trying to dissuade someone from having an abortion, or attending a pro-life event. This section does not have to be long, but should include enough detail to give the selection committee a good idea of the kind and extent of your pro-life involvement.
2. Provide two letters of recommendation from adults who are familiar with your pro-life involvement. These persons are to be non-relatives. These references could be written by a pastor, a pro-life leader, a teacher, or some other adult familiar with your pro-life convictions and activities.
3. In 2 to 4 pages, double-spaced, write an essay on a pro-life topic such as abortion, infanticide, euthanasia, stem-cell research or what is happening now that the Supreme Court struck down Roe v. Wade. Another possible topic would be to discuss local resources that are available for women and their babies in our area, such as the pregnancy help centers and Safe Haven Baby Boxes. You are encouraged to do some background research for this essay and are not limited to these topics. The essay, however; must be on a pro-life topic.
4. Please be sure to include your name, address, phone number, e-mail address, name of school you are currently attending and the name of the college (if different from current) that you will be attending.

Evaluation Criteria

1. Involvement in Pro-Life activities
2. Demonstration of leadership qualities
3. Ability to communicate your pro-life beliefs

The complete application must be received via email no later than Thursday, February 20, 2025. Email to rtlsoind@gmail.com

Board members of Right to Life of Southern Indiana will evaluate applications. All students submitting applications will be notified of the outcome. The Scholarship will be awarded at the Oratory Contest, March 6, 2025, that will be held at Our Lady of Perpetual Help Catholic Church, 1752 Scheller Lane, New Albany, IN. The contest begins at 6:00 p.m. The winner is encouraged to arrive no later than 5:45 p.m. If the winner is unable to attend, a parent may accept the scholarship at the event. Scholarships will be paid directly to the school to be used for tuition or books.
