

2026-2027 Universal Choice Scholarship FAQs*

What does Universal Choice mean for families?

- Universal Choice will remove the income guidelines from the current list of eligibility requirements for the Choice Scholarship (Indiana voucher) **effective 7/1/26** for our families, making the Choice Scholarship available to ALL Indiana residents with students in grades K-12.

Once Universal Choice goes into effect, will there be ANY requirements to receiving the scholarship?

- Yes, students will need to have legal settlement in Indiana and be in grades K-12 for the 2026-27 school year.

How much is the Choice Scholarship (voucher)?

- Vouchers are based on the county (school system) where you live. To find your estimated voucher, click [here](#).

Do I need to do anything to receive the Universal Voucher?

- Yes, you will need to review and sign Choice Scholarship application paperwork for your student(s) that we will submit on your behalf. After 7/1/26, we will begin processing Choice Scholarship applications for all K-12 students who reside in Indiana who did not previously submit our Tuition Assistance or Choice Scholarship Only Application through FACTS. We will email your application paperwork to you to sign and once completed, your student(s)' voucher(s) will be applied to your payment plan. Please note that families will make full tuition payments starting in June until this process has been completed.

What if I need the Choice Scholarship on my 2026-27 payment plan prior to my June payment?

- You must meet current eligibility requirements, which **includes** the income guidelines. To apply, submit the Choice Scholarship (Voucher Only) application and all required income documentation by **March 13, 2026**. You may complete the application using the link below:

Why do I need to submit income documentation for the Choice Scholarship since the Universal Choice legislation passed?

- Indiana legislation does not go into effect until 7/1/26. Therefore, the income guidelines remain as an eligibility requirement, and we are unable to process Choice Scholarship applications for students prior to 7/1/26 without income verification. We cannot apply vouchers to payment plans without completed Choice Scholarship applications.

What if I do not wish to participate in the Choice Scholarship program?

- Families who do not wish to participate in the voucher program can let us know that they wish to opt out when they receive their Choice Scholarship application notification via e-mail. Simply reply to that email that you would like to opt out of receiving the Choice Scholarship for your student(s).
